

Grant Funds Education on Labor Compliance

Louisville, KY – AgSafe, a national non-profit with a direct Kentucky connection, has been awarded a \$33,857 grant through the Southern Center for Extension Risk Management Education to provide education on labor compliance and best human resource practices.

Labor is business's most important resource as well as its greatest liability and the agriculture industry is no exception. Labor laws and regulations are complex, coupled with the fact there are 9 different agencies which have oversight on agricultural industry. Labor violations can be well over \$10,000 per citation and essentially crippling to an operation of any size.

The grant has funded the planning and development of a 2-part education series with multiple interactions. First, inperson workshops will walk participants through various labor options and the accompanying laws and regulations. Second, individuals have the opportunity to join a webinar series to understand best human resource practices to not only increase compliance but overall hiring, management, and retention of farm employees.
